Upgraded AMP and Market Messenger Service



The agricultural markets are still volatile, and that means money flying into and out of your farming enterprise. **Ag Marketing Professional** risk management and cash sale recommendations are a valuable tool in your operation, but you don't spend all day at your computer. Do you wish that you could receive all **Ag Marketing Professional** recommendations as soon as they are released, and wherever you are, so that you can react quicker? Do you have a cell phone? We can deliver!

The new Market Messenger 2 service from Brugler Marketing & Management LLC includes not only the current Market Messenger USDA report alerts and emergency advice via audio message, but also two powerful new features.

1) You can now receive all of the ***** Red Asterisk** action items from the daily **Ag Marketing Professional** newsletter via a text message to your cell phone as they are released in the morning or during the day. This includes cash, futures, options, basis and LDP recommendations. Due to the message length limitations of 110 characters, each commodity recommendation will be sent as a separate text message. You customize the service for the commodities you wish to receive.

2) Daily audio messages with all new recommendations summarized in one phone call for grain items and one call for livestock.

You will still have to read the email or visit the web site for the full fundamental and technical details behind the recommendations (which in fact can be done already via either a laptop computer with a wireless card or on most smart phones with a data package or email forwarding to your phone), but the actual action items will reach you much quicker with the MM2 service and you won't have to worry about writing numbers down wrong because you will see them in the text message. We've all heard the phrase "Time is money".

Because Ag Marketing Professional is a hedging and price risk management consulting service, and not a speculative service, all risk management recommendations will be sent out, whether cash, basis, futures, options, LDP, etc. The choice of text or voice messages is yours.

IMPORTANT: MM2 service does not include the cost to receive text messages on your cell phone. If you do not have a bulk text messaging package on your phone, we strongly encourage you to get one from your cell phone carrier if using the text message option, as the per message charges can add up quickly.

You **MUST** be an **Ag Marketing Professional** client to receive MM or MM2 services. You may have either the Premium or No Call AMP service versions.

How do you get started with MM 2? We need to know the specific commodities for which you wish to receive alerts, so as to not overburden your phone with messages. You will also have to elect the new Market Messenger 2 service option you desire, and pay the subscription fee for this enhanced service to activate it.
